



**BEACH CITIES HEALTH DISTRICT BEGINS EIR PROCESS FOR  
PROPOSED HEALTHY LIVING CAMPUS MASTER PLAN;  
PUBLIC SCOPING MEETINGS SCHEDULED FOR JULY**

***Scoping process offers opportunity for public to comment regarding  
environmental effects from modernizing 11-acre Redondo Beach property***

**REDONDO BEACH, Calif.** (June 28, 2019) -- More than two years of meetings and workshops with residents, community leaders and business owners; city leadership and staff; and finance, design and architecture experts have led Beach Cities Health District (BCHD) to the next stage of the organization's proposed Healthy Living Campus Master Plan: the Environmental Impact Report (EIR).

BCHD is preparing an EIR as the Lead Agency as required by the California Environmental Quality Act (CEQA), with Wood Environment & Infrastructure Solutions, Inc., serving as EIR consultants for the project. The state-mandated EIR, which is expected to be completed in early 2020, will inform the public and project decision-makers about significant environmental effects at the Redondo Beach site and identify possible ways to minimize or avoid those effects.

The EIR process begins with a 30-day period for "public scoping," the opportunity for responsible agencies and the public to comment on the scope and content of the EIR. The EIR preparers will consider this information in developing the public draft EIR. Three formal public scoping meetings will be conducted in July that are open to all members of the public. Each meeting will run from 6 to 8 p.m. and have an "open house" format, with a brief presentation from 6:45 to 7:15 p.m.

A scoping meeting specifically scheduled to accommodate working hours of public agency representatives is planned for Monday, July 15 from 2 to 3:30 p.m. in the Beach Cities Room (Lower Level) at 514 N. Prospect Ave., Redondo Beach.

The 30-day public review period for submitting comments on the scope of the Draft EIR began June 27 and all comments must be submitted no later than 5:00 p.m. July 29, 2019.
